Spring Applications: For applications made in the spring or early summer, use 3-5 pounds of product per 1,000 sq. ft. depending on crabgrass pressure. The duration of residual weed control provided by this product is directly related to application rate, but will vary somewhat depending on weather, weed pressure, turfgrass competitiveness, and the user's location within a region.

This product provides "pre-emergence" control for use on crabgrass in established turfgrasses (including the large, smooth, and southern species) when applied prior to germination and emergence of crabgrass.
