YOUR SUMMER HOME IMPROVEMENT PROJECT CAN PREVENT CRIME, PART 3

The National Institute of Justice shows that Crime Prevention Through Environmental Design (CPTED) [is effective](#) at reducing crime.

CPTED uses landscaping, architecture, and home-design to reduce opportunities to perform and conceal crime and evoke a sense of neighborly cohesion and care.

We're highlighting a principle of CPTED one-at-a-time to inspire you to make your summer home-improvement project also a crime-reduction project.

Principle 3: provide for a well-maintained image

Criminologists have long posited a link between crime and a community's appearance.

A messy, neglected space could imply that 'no one cares' about crime (or are at least willing to ignore it) while a well-maintained space might declare to wrong-doers that a community can effectively notice, find, and punish them.

By freeing your neighborhood of litter and graffiti, maintaining your landscaping and home's exterior, and transforming vacant spaces into pleasant, intentional spaces, you both beautify your neighborhood and convey the message that "crime isn't welcome"
